Meeting purpose

The third meeting of the community representatives to agree the candidates to invite to meet to discuss the chair position, discuss the format for the meetings, and discuss how to engage the community on the chair decision.

Introductions

- A one-minute silence was held at the start of the meeting.
- A new member of the Memorial Commission, representing the former residents of Grenfell Tower and Grenfell Walk in place of the member who recently decided to stand down, was introduced to the Commission and welcomed.

Actions from previous meetings

- Secretariat to produce business cards for the Commission ongoing.
- Secretariat to explore alternative methods for the Commission to write to residents – ongoing.
- Secretariat to provide examples of potential ways of working once the chair is in place ongoing.
- Secretariat to explore options for building a reserve pool in the event of potential future representative positions becoming available - ongoing.
- Secretariat to trial sending meeting papers via an online portal instead of via email – ongoing, portal being developed
- Secretariat to explore push notifications as a wider community communication method – ongoing.
- All other actions are closed.

The chair and patrons

 The community representatives agreed to meet four candidates to further discuss their interest in the chair role. The community representatives agreed that the secretariat should approach an additional individual to gauge their interest for a chair or patron role. The community representatives also considered possible patrons and agreed for the secretariat to approach individuals and report back.

- The community representatives discussed the format for the meetings with the
 chair candidates and that they will be interested in establishing the candidates'
 approach to working with communities to build trust on sensitive issues,
 working collaboratively with others to deliver outcomes, and how they bring
 together conflicting views to achieve a consensus.
- The community representatives also discussed how to engage the community on the chair's selection and the format for the community meetings.
- Action: Secretariat to arrange for the four candidates to meet the
 representatives and approach the additional suggested individual.
 Action: Secretariat to update the community representatives on individuals
 interested in supporting the Commission as patrons.
- Action: Secretariat to circulate draft questions for chair candidates, for the community representatives to consider.
 Actions: Secretariat to produce a proposal for community meetings, for the

community representatives to consider.

Public authorities

- The recommended representative for MHCLG excused themselves for this discussion.
- The community representatives agreed to ex-officio membership on the Commission for public authorities and agreed with the recommended individuals for CNWL, GLA, and MHCLG. They asked that RBKC consider putting forward an additional representative for them to consider.
- **Action:** Secretariat to contact RBKC and request that they put forward at least one more candidate.
